## Pilot unhurt in emergency landing

LIVINGSTON TOWNSHIP — A pilot was unhurt when his plane flipped upon making an emergency landing in a cornfield north of Gaylord Tuesday evening.

Pilot Dan Kovaric, age 28, of Huntington Woods, was the lone occupant of the Cessna 150 single-engine plane.

According to Kovaric, the airplane lost power at about 3,000 feet. As he prepared to land on a grass field the plane's engine restarted at approximately 500 feet, causing Kovaric to try flying his plane to Gaylord Regional Airport rather than make the landing. The engine cut out once again, forcing Kovaric to land in a cornfield.

"I touched it down in the corn and tried to keep the nose up as long as I could," Kovaric said, explaining how he wanted to keep the front landing gear from digging into the soft dirt. Once it did, the airplane tipped tail up and paused before falling onto its top.

"It looks a lot worse than it was," he said.

"We emphasized emergency landings, and when it came time he did everything right," said Kovaric's flight instructor, Wally McCoy, who came to the scene after Kovaric's hard landing.

The plane, built in 1971, belongs to Mike Head of Traverse Lakes Aviation, based at Gaylord Regional Airport.

Kovaric is in town for a golf outing and had been flying to log hours on his pilot license.

The National Transportation Safety Board had been notified of the crash and was planning on sending a crew to investigate Wednesday morning.

Responding to the scene were the Michigan State Police, Otsego County EMS/ Rescue and Otsego County Fire Department.

# Airport restaurant to reopen under new management

MASON CITY — The restaurant at Mason City Municipal Airport will reopen Sept. 1 with an emphasis on providing patrons breakfast or lunch during all working hours.

"If you want bacon and eggs at 2 o'clock in the afternoon, you've got it. If you want a hamburger at 7 in the morning, you've got it," said Robert De Los Santos, who will manage the restaurant with his daughter Maria.

De Los Santos has been in the restaurant and food service business for 20 years.

The restaurant will serve traditional breakfast items — eggs, toast, bacon sausage, hash browns and pancakes — and typical lunch items such as hamburgers, hot dogs and corn dogs.

In addition, said De Los Santos, the menu will include some Native American specialties in honor of his ethic background. Desserts will also be served.

Restaurant hours will be 6:30 a.m. to 5 p.m. Sunday through Friday and 7 a.m. to 4 p.m. on Saturdays.

He said the restaurant will continue to be called the Airport Cafe.

"That way, everyone will know where it is. The name says it all," said De Los Santos.


Hanna Bolinger operated the cafe from March 2001 until Memorial Day weekend this year, according to Pam Osgood, airport manager.

## John And Martha King Held At Police Gunpoint (Really)

Aviation's most prominent husband and wife team is calling on government agencies to keep their databases up to date and warning pilots and aircraft owners they could be next to be surrounded by heavily armed police, handcuffed and detained because of a bit of miscommunication. John and Martha King say there's a lesson to be learned after they spent about 30 scary minutes in the custody of Santa Barbara, Calif., police at the Santa Barbara Airport Saturday. Authorities thought their leased Cessna 172 was a Cessna 150 that had been stolen eight years previously in Texas. The 172, which is owned by Cessna Aircraft, was assigned the N-number of the stolen 150 in 2009, years after the FAA had cancelled that registration on the 150. Apparently no one told the El Paso Intelligence Center, an arm of the Drug Enforcement Agency, and other government departments that keeps tabs on, among other things, flights of stolen aircraft. When the Kings filed IFR for their flight from San Diego to meet friends in Santa Barbara, the local police were alerted to intercept the aircraft when it landed. As Martha King told us in the accompanying podcast, what followed was, in her opinion, unnecessarily dangerous and uncomfortable.

King says they were approached by police prepared for the worst, with guns drawn and others taking cover behind the doors of the four police cars that responded. Although anyone who has met the Kings would describe them as anything but threatening in appearance and demeanor, the police took no chances and maintained their aggressive stance through the ordeal. "I would have thought at that point when they got us out it would have ratcheted down quite a bit because I don't think we exactly look like your typical airplane thief," she said. The Kings were not hurt and the airplane was not damaged. The police did not apologize but did justify their actions by saying it was a report that had to be checked out, King said. The Kings said they went public with their experience in hopes that law enforcement agencies will double-check stolen aircraft reports and to warn pilots that there's a chance their N-number could come up under similar circumstances.
